As a grassroots community representative, she brings a personal commitment, professional expertise, and community-centered approach to participating in the community's civic and political life.

She is embedded within a community that she has helped educate and mobilize with historic civic and electoral firsts throughout North County. Being part of the movement to build people power has given her first-hand knowledge of privileges and barriers affecting civic participation among immigrants and Latinx communities who are still grossly underrepresented in key positions. She is dedicated to promoting precious ancestral knowledge, community service, and civic participation.

She is a Chicana immigrant who came from Mexico and settled in San Marcos when she was 12 years old. She was raised by a single mom who worked tirelessly in sewing factories earning minimum wage to afford basic necessities for six daughters. She understands first hand the struggles immigrant families face in San Diego County and embraces the opportunity to serve our community.





#### **DR. CARMEN ROJAS** President & CEO, Marguerite Casey Foundation

Dr. Carmen Rojas (she/her) is the president and CEO of the Marguerite Casey Foundation. Prior to joining Marguerite Casey Foundation, Dr. Carmen Rojas was the co-founder and former CEO of The Workers Lab, an innovation lab focused on making real the promises of safety, dignity, and mobility to all working people. For more than 20 years, Carmen has worked with foundations, financial institutions, and nonprofits to improve the lives of working people across the United States.

She is a mother of 5 and has raised her children with her husband on both Santa Ysabel Reservation and Manzanita Reservation. Carrying out the preservation of cultural resources and active revitalization of Kumeyaay traditional life ways within her family and communities.



#### **CHRISTINA SNIDER** Tribal Affairs Secretary to Governor Newsom

Christina Snider serves as Tribal Affairs Secretary to Governor Gavin Newsom and leads the Governor's Office of Tribal Affairs established within the Office of Governor Gavin Newsom on July 1, 2022. Snider was appointed February 19, 2019 by Governor Newsom to continue her service in the Governor's Office following her appointment on February 6, 2018 by Governor Edmund G. Brown Jr. On July 1, 2020, Snider has also previously served as Executive Secretary of the California Native American Heritage Commission, appointed by Governors Newsom and Brown. She is an enrolled member of the Dry Creek Rancheria Band of Pomo Indians.

As a member of the Cabinet, Secretary Snider serves as the Governor's Tribal Advisor and oversees effective government-to-government consultation between the Governor's Administration and California tribes; informs, develops and implements policy directives related to tribal governments and Native American communities; leads the California Truth δ Healing Council and California Indian Heritage Center Task Force and oversees the Tribal Nation Grant Fund Program.

In addition to her duties leading the Governor's Office of Tribal Affairs, Secretary Snider serves as a member of the California Broadband Council, the Judicial Council Tribal Court-State Court Forum and an ex officio member of the California Advisory Committee on Geographic Names.





#### **EMILY BURGUENO** Head Seed Keeper, Maat Hetemii

Emily Burgueno is an enrolled citizen of the Iipay Nation of Santa Ysabel which is one of twelve bands. Ms. Burgueno's commitment as the Head Seed Keeper at Maat Hetemii (the local community garden on the Reservation). Here she has developed a space to prioritize the Tribal Members' wellbeing with the support and foundation of her mentors. Ms. Burgueno is rooted in the Kumeyaay life ways she was raised with and tries to implement these teachings in her daily work for the community and land. One of Ms. Burgueno's many goals is to support rematriation throughout the Kumeyaay Nation. "Rematriation" can be defined as: "to restore a living culture to its rightful place on Mother Earth," or "to restore a people to a spiritual way of life, in sacred relationship with their ancestral lands, without external interference." As a concept, rematriation acknowledges that our ancestors lived in spiritual relationship with our lands for thousands of years, and that we have a sacred duty to maintain that relationship for the benefit of our future generations.

From learning and teaching, Emily knows the importance of the relationships we develop within ourselves, our community/ecosystems, and the natural world.

Kris Lin-Bronner is the Executive Director & Chief Grants officer of Dr. Bronner's Family Foundation, which supports the humanitarian goals of the descendants of E.H. Bronner, founder of Dr. Bronner's, the top-selling brand of natural soaps in North America. Kris oversaw the creation of Migration Justice Initiative, which is dedicated to serving refugees, displaced persons, and forced migrants, and is responsible for the program's administration. Prior to taking charge of the foundation, Kris worked as the Strategic Adviser and Corporate Social Responsibility Manager for Dr. Bronner's. She oversaw and managed many diverse projects under the umbrella of sustainability and social responsibility, including advising the company's Fair Trade supply chain projects on financial and operational matters, providing integrated risk assessments on new business ventures, and worked to institutionalize Dr. Bronner's sustainability efforts across multiple levels of the company, from operations to governance. While at Dr. Bronner's, Kris guided the company through the process of becoming a benefit corporation in California and a Certified B-Corp.

Kris earned an undergraduate degree in English Literature from Harvard University and a graduate degree in International Affairs from UCSD. She is a hospice volunteer, a design enthusiast, and enjoys adventure travel. Kris was born in Taiwan, emigrated to the United States at the age of 12, and currently lives in Oakland, California.





#### **LISA CUESTAS** President & CEO, Casa Familiar

Lisa Cuestas is currently Chief Executive Officer of Casa Familiar, a 501(c)(3) non-profit community-based organization in San Ysidro, CA. Lisa has worked for Casa Familiar for 20 years and nearly 25 years of experience in the non-profit sector. She is the embodiment of an emerging Latina leader. She is a Fronteriza – raised along the U.S./Mexico border. Her mother is from Ciudad Juarez and her father from Tucson, Arizona. Lisa's parents and grandparents imparted on her the importance of community and the notion of rising by uplifting others, which are the values she and her husband are now passing along to their own children. Lisa has committed her life in service to her communities and this trajectory has led to becoming the Chief Executive Officer for Casa Familiar (Casa), a community service and development agency dedicated to ensuring residents of San Ysidro and the South Bay have a leading role in all aspects of the development and sustainability of their community.

As Casa Familiar's Chief Executive Officer, Lisa oversees an annual budget of \$5.0M+ with a growing portfolio of 1,300 affordable housing units in San Diego's South Bay. Under her leadership, Casa Familiar secured \$10 million of New Markets Tax Credit Financing in 2018 for its Living Rooms at the Border project completed in February of 2020, a 13,469 square- foot mixed-use project in San Ysidro, a predominantly Latino community in San Diego. Lisa holds a bachelor's degree in Human Services and Management from the University of Phoenix.





### **OMAR LOPEX** Director, Standard Fantastic Pictures

Omar Lopex is a writer, director, artist, and academic whose work has been exhibited at Big Muddy, San Diego Underground, and Harkat 16mm Film festivals, as well as the Mingei International Museum, San Diego Museum of Art, La Jolla Athenaeum, and Shakespeare and Company Paris. He is the recipient of grants from American Artists, the Avery-Tsui Foundation, and the William Male Foundation. Lopex shoots exclusively on celluloid film and won the Binational Filmmaker Award for his debut feature Ana, Who They Pulled Out of the River from Film Consortium San Diego 2018.

Lopex helms Standard Fantastic Pictures, an artist-run production studio emerging from the front lines of cross-border politics and whose collaborative form of production values the unique Cultural Capital of the Transborder Region. By centering Transborder experiences, Standard Fantastic disrupts an existing system of marginalization and cultivates a community of inclusion; providing the resources, care, and support for projects the Hollywood film industry ignores.

In 2022, Lopex established the inaugural Standard Fantastic Transborder Film Fellowship providing materials, equipment, and mentorship for two teams of young filmmakers to produce narrative films about the border. He also serves on the Advisory Council Board for the Suraj Israni Center for Cinematic Arts at the University of California San Diego.





## **PAUL CUERO** Cultural Icon, Campo Kumeyaay Nation

Paul Cuero, Jr. is a leader, mentor and cultural icon of the Campo Band of the Kumeyaay Nation. Since the age of 19, he has been involved in various aspects of tribal government, serving as treasurer and chair. He played a crucial role in drafting, analyzing and refining the California Native American Graves Protection and Repatriation Act. In 2010, KPBS recognized him as an American Indian Heritage Month honoree.

Cuero is nationally known for his mastery of a cycle of songs named for the takut. These cultural bird songs, of which there are 300 in the takut cycle, are a metaphor for life. Cuero and a group of Kumeyaay youth performed the bird songs with the San Diego Symphony Orchestra in a composition that bridged the gap between traditional indigenous and contemporary American cultures. He was also invited to sing at the White House during President Bill Clinton's tenure, at the opening of the National Museum of the American Indian and at the pre-game ceremony for the 1998 Super Bowl in San Diego.

Chairman Cuero is a leader in educating young people about bird singing and other powerful traditions of the Kumeyaay people. From an early age, he sought guidance from the elders in his pursuit of knowledge about tribal history and mythology. Now, as an elder himself, Cuero works to convey not only the tribal histories, but also the philosophy and spirituality implicit in them. He is a staunch advocate for education as a path to leadership and cultural pride for Indian youth.

In recognition of his dedication to serving and celebrating the Kumeyaay, other Tipai American-Indian cultures and indigenous communities all over the world, the Board of Trustees of the California State University and San Diego State University are honored to confer upon H. Paul Cuero, Jr. the honorary degree of Doctor of Humane Letters.





**ROSA DIAZ** CEO, The Imperial Valley LGBT Resource Center Rosa was raised in Brawley, California. After graduating from high school, she moved to Los Angeles County and received a bachelor's degree from a four-year college in La Puente, CA. After 13 years in corrections, retired and started a social work job with Imperial County.

After "coming out" as a lesbian, Rosa found a lack of LGBT resources in the Imperial County and, in search of community, founded the Imperial Valley LGBT Resource Center in 2015.





#### **STEPHEN MINIX** Senior Director Community Strategy, UpMetrics

Stephen joined UpMetrics in 2015 for one reason: a unique opportunity to continue to uplift communities. In his role as Senior Director of Community Strategy Stephen empowers partners to utilize their data to accelerate progress toward outcomes: informing all decisions, gaining new insights and telling their story to a wider audience. Stephen is passionate about building capacity at impact organizations as he has dedicated his life's work to the advancement of youth and communities through education and development.

He began his career by serving young people and communities in Southern California as a public school and public charter school teacher, coach, athletic director, administrator, district coordinator for afterschool programs and adjunct professor. He was recognized as the CIF Los Angeles City Section Athletic Director of the Year in 2015. Today, Stephen continues to be active in the community, serving as a Green Dot Public Schools Ambassador, and an inaugural board member (board chair) for MENTOR California.

Stephen graduated from Pepperdine with a BS in Physical Education and a MA in Secondary Education. Stephen is married with three young daughters and is a #girldad for real!!



VINCE POLLIZZI Program Manager, Imperial Valley LGBT Resource Center Vincent Pollizzi brings a unique combination of skills to the working environment. Early jobs showed him the value of good customer service and the importance of doing the job right. Through his time in the military, he learned a strong work ethic and dedication that serves an organization well and makes him an employee others can rely on to get the job done. Vincent can face the challenges of more extensive projects and balance the daily routine of emails, phone calls, spreadsheets, and grant reports. With several degrees in engineering, instructional design, career and technical education, and a decade in front of the classroom, his career path has seen him repair all types of equipment and manage warehouses full of goods and people. There is little he has not taken on during the work week.

Starting his volunteer work at the center shortly after moving to Imperial County, California, in 2017 by running generators for parades and hanging mirrors, the scope of work he has faced has steadily expanded. While working with the Imperial Valley LGBT Resource Center, Vincent has become a member of an organization that works to help the community in many different ways. His current responsibilities capitalize on the background of program organization, logistical support, and detail management. These efforts allow others in the organization to focus on their strengths - peer support, counseling, and behavioral and mental health. By supporting the efforts of staff and volunteers in the organization through managing the supplies, administration, and logistical challenges faced daily, Imperial Valley LGBT Resource Center can help more people and develop additional programs that benefit the county.

In summer 2021, Vincent led the Youth Cadet Academy and worked with center staff to coordinate the Summer Splash Pool Blast as one of many events to support the center's grant-funded work. The center helps individuals and families complete applications and offers peer counseling, DV and AM classes, and numerous community-centered events throughout the year. These efforts have led to the current position of Program Manager, where he is responsible for supporting the staff, volunteers, grantees, and all the activities the center provides to the community. With the center's recent acceptance of several grants targeted at supporting the community through the pandemic by sharing the latest news and information from trusted and reliable sources, the work will not end soon.





### **VINO PAJANOR** CEO, Catholic Charities Diocese of San Diego

Vino Pajanor is the CEO of the Catholic Charities Diocese of San Diego. Vino's life journey has uniquely prepared him to steward this vital ministry. Born in India, he ventured towards a professional career as an attorney where he practiced law before moving in 2000 to the United States to continue his professional and personal development by attending the USD School of Law on scholarship, earning an LLM degree. Subsequently, he worked at one of San Diego's leading law firms, and then Vino discovered his heart's passion for nonprofit work when in 2006 he co-founded the Housing Opportunities Collaborative to address the growing predatory lending practices and evolving housing crisis where he created the Virtual Counselor Network to improve the delivery of counseling services to the community through technology.

In 2016, he successfully graduated from Achieving Excellence in Community Development program at the Harvard Kennedy School of Government. He led an international real estate development company before the job opening at Catholic Charities inspired his return to the nonprofit sector. With "a nonprofit heart and a forprofit mind," as Vino describes it, he connects deeply to the mission of Catholic Charities by ensuring the agency has robust financial with a triple bottom line framework, SMAART goals, and organizational means to live out its Matthew:25 calling with excellence.
