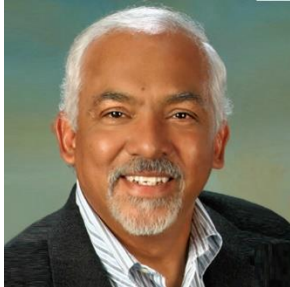




Cynthia Ajani

Under his leadership, the Ford Institute adopted a community building approach that supports residents in taking the lead to create the change they want to see. At the Jacobs Family Foundation in San Diego, Roque worked as the director of community building and served as interim president. While at the Jacobs Family Foundation, he led resident teams to develop the vision and implementation of Market Creek Plaza in Southeastern San Diego, a community building and economic developed project. In the nonprofit field, Roque served as the director of U.S./Mexico Projects with Los Niños, an international community development organization and later served as its executive director for 10 years. He has developed and directed sustainable programs that assist communities in finding opportunities, addressing their needs and developing solutions. He has also designed capacity building trainings and toolkits for resident-led community building efforts.

Barros was born and raised in the Imperial Valley and is excited to return and lead IVWF's vision of healthy people living full lives in the Imperial Valley and responding to needs and opportunities while building for the future. In partnership with the Alliance Healthcare Foundation, the goal is to have a \$25 million endowment in place that will provide more than \$1 million to the community each year to address health and wellness issues for the most vulnerable in the region.

Since joining The San Diego Foundation on June 1, 2020, less than three months after the beginning of the COVID-19 pandemic, Gray Payton has played a key role directing work related to The Foundation's \$66 million COVID-19 Community Response Fund (CRF). In less than 15 months, the CRF provided grants to more than 380 nonprofits providing more than 2.5 million services to San Diegans in need. Gray Payton has also played a key role with shaping The Foundation's strategic plan and launching its Black Community Investment Fund. In her role as Chief Impact and Partnerships Officer, Vice President of Community Impact, she oversees The Foundation's Community Impact programs and leads the strategic initiatives that enable community solutions to improve the quality of life and advance a vision of just, equitable and resilient communities in the San Diego region. Gray Payton also plays a critical role in developing cross-sector partnerships on behalf of The San Diego Foundation.

Lorraine grew up on the San Pasqual Indian Reservation. Attended UCSD, University of California, San Diego and obtained a BA in Sociology and Ethnic Studies. She also holds a Masters / MS in Education from National University.

Lorraine has worked in Education for the local Native American community for 29 years. The past 17 years she has been developing the current Department of Education for the San Pasqual Tribal Government, as the Executive Director for the Tribe's Department of Education. Currently Lorraine is on the Board of director's for Kumeyaay Community College ([HOME PAGE - Kumeyaay Community College](#)). She is also on the Native American Advisory Board for the California State University, San Marcos.

As the Executive Director of the San Pasqual Education Department, she develops and implements a variety of community-based Education programs. Programs include Early Childhood Education, K-12 Educational support services; tutorial, college career planning, and also, wellness and preventions programs, Inter Tribal Sports League, college classes on-site, Kumeyaay Language, Culture and Traditional student classes and programs. The Kumeyaay territory is Southern California to Arizona, which also crosses South to the into Baja Mexico.

In his previous role as Director of Racial Equity Initiatives for Borealis Philanthropy, Marcus lead the Racial Equity Initiatives team and worked in partnership with 18 nationally-networked, philanthropy-serving grantee organizations to move past the “transactional” nature of Diversity, Equity and Inclusion to a unified movement which prioritizes strategies that close gaps in access to opportunity, resources and well-being (across all categories of gender, identity, sexual orientation, class and ability).

Before that, Marcus served as Vice President and Chief Operating Officer for the Association of Black Foundation Executives (ABFE), where he oversaw its operations, HR and staff development functions, including the overall strategy, conceptualization and administration of racial equity programming. Prior to ABFE, he combined his organizing experience and passion for public service in the role of Program Officer of Community Responsive Grantmaking with the Cleveland Foundation and Sr. Program Officer with Neighborhood Progress, Inc.

Marcus is a Newfield Network-trained ontological coach, with additional training in the Action Learning systems coaching model. He promotes coaching as a tool for personal mastery, racial equity & systems change, social sector excellence and transformation within marginalized communities.

Marcus received a Bachelor of Arts in History and Political Science from Bowling Green State University and has continued graduate studies in public administration at Georgia State University’s Andrew Young School of Public Policy as well as Rutgers University’s School of Public Affairs and Administration.



Jason Wells
Chief Executive
San Ysidro Chamber of Commerce

Jason M-B Wells, 47, is the chief executive of the San Ysidro Chamber of Commerce, where he represents commerce at the World's busiest land-border crossing. A skilled negotiator and avid consensus-builder, Wells is responsible for building, among other strategic partnerships: the San Ysidro Smart Border Coalition in 2007 – bringing federal attention and change to his tiny, yet powerful border-community, including two new, international pedestrian crossings; the Binational Chamber of Border Commerce in 2010 – a historic conglomeration of economic development organizations from both sides of the US/ Mexico border; and creation of the Border Public Arts Committee in 2015.

In addition to representing San Ysidro businesses, Jason was publicly elected in 2010 to the San Ysidro School District Governing Board, where he was voted by his peers as the President of the Board in 2013 and, in 2014, was the first re-elected President for the district in over 20 years. Completing a term of service to the community, Wells was responsible for leading the district through an administration overhaul, implementing historic "local control funding" mechanisms and negotiating the district out of a teacher's strike by reaching out to union representation and finding a compromise that gave teachers more than expected and set the district on a path to fiscal solvency.

"Proactive" and "Results-Oriented" are two of the most used adjectives in describing San Ysidro's charismatic executive – resulting in several appointments from both San Diego's Mayor and recent Mayors of Tijuana.

In 2020, Wells was hand-picked by then-San Diego mayoral candidate Todd as part of his small business task force, then appointed by Mayor Gloria as part of his Back To Work San Diego team. Besides Back To Work SD, Jason sits on the Civic San Diego New Market Tax Credit Advisory Board, San Diego Police Chief's Latino Advisory Board, San Diego PD Southern Division Captain's Advisory Board, elected member of the San Ysidro Community Planning Group and the US Customs and Border Protection Port Working Group – San Ysidro.
